- b. Shake It Up: Request was made from owner to amend the agreement for a reduction in percentage due to NMSSA.
  - i. Board discussed various ideas to better support our vendors
  - ii. The board voted to maintain consistency with all sponsor contracts and not amend the contract with Shake It Up as requested by them.
- 4. Mission of NMSSA
  - a. Discussion proceeded about changes to make to the mission statement within the bylaws as well as on the website.
    - i. Board voted to change Bylaw 102 to update verbiage and include a more broad statement
  - b. 2026 Mission Statement:
    - i. The board discussed which three areas NMSSA should focus on for the coming year.
      - 1. Growing the game of soccer
        - a. Assisting leagues and maintaining any growth made
        - b. Assisting any new program additions
      - 2. Run 3 successful tournaments
      - 3. Participate in 4 community outreach events
    - ii. The mission of NMSSA is to grow and strengthen the game of soccer by expanding participation, supporting leagues, and encouraging new program development. We aim to deliver quality competitions and tournaments while engaging with our community and providing leadership and resources that create sustainable, accessible, and positive soccer opportunities.
- 5. Current status of website and registration platform
  - a. Audrey reviewed current contract with SportLomo
  - b. All leagues have been built into the registration platform
- 6. Current status of each league
  - a. MAFL is currently not in good standing due to being late on affiliation paper, quarter 4 payment, and SafeSport certifications. James will issue a letter of non-compliance.
  - b. Zia League: Number of teams is down.
  - c. Momentum: Pick up soccer to launch in Spring/Summer 2026
  - d. Gallup: In the registration process
  - e. MVSL: The numbers for the upcoming tournament are low
  - f. SCSC: Are getting ready to start their season.
  - g. SFASL: Are getting ready to start their season as well.

- a. Tina touched on the contract with WaveOn Health and the payment plan.
  - b. Tournament Budgets
    - i. Tournament pass will be the same cost as the annual pass.
    - ii. Tournaments for the coming year need to either break even or making at least a minimal profit
      1. Tina proposed to increase team registration fees by \$100
      2. Tournaments will need to be canceled if they are projected to lose money
      3. To save costs
        - a. Medals can be repurposed by ordering new ribbons
        - b. Repurpose t-shirts in some manner
        - c. Fundraising night at a restaurant for Dog Days
        - d. Decrease the number of places that receive medals as well as decreasing the amount of medals each team will receive.
