- a. NMSSA will be strategizing fundraising opportunities to assist with the travel expenses for the women's team.
  - b. Have been in contact with NPSL and they will be sending teams to the regional cup. Audrey will be working in partnership with them and MVSL since they have a team in El Paso and need more local games that count towards their 10 week season.
  - c. At this time, there is no men's team interested in attending the regional cup. A proposal was made to make an offer to send an MVSL's men's team.
3. Tournaments
- a. Dog Days
    - i. Reviewed previously discussed conflict regarding the currently planned dates and discussed alternate date possibilities.
      1. Options for dates: Stay at the currently planned dates (4th weekend of July) or move up one week to the 3rd weekend of July.
        - a. Consensus was moving it up by one week. Audrey will look into field availability and how to view the world cup games during the tournament.
    - ii. Discussed increase of team fees. Also discussed, a proposal to move from a team fee system to a per player fee system. A bond of \$200 to be imposed, that is to be paid back once they meet their player minimums. Audrey to gather feedback from teams who have already expressed interest in Dog Days regarding this proposal.
  - b. Freedom Cup
    - i. Discussion occurred regarding dates, interest in the tournament, and canceling the tournament if there is not enough interest.
      1. Proposal was made and seconded to draft up a budget by the end of April with a profit of \$500 to \$1000 needs to be drafted and a guarantee of 12 teams interested to keep the tournament in the books to not cancel.

4. Raffle/Fundraiser event recap - postponed to next board meeting.

5. World Cup Watch Party with NMYSA

- a. NMYSA reached out to propose a joint watch party for youth and adults on June 25th. More information to follow. Potentially an all day event at Mesa Del Sol.

- a. Reviewed league numbers and player data for Q1
- b. Reviewed upcoming seasons for various leagues and the prospective numbers going into the remaining quarters.
